**PAYMENT TERMS:**

- Monthly statements are generated the last day of the month with payment due on the 15<sup>th</sup> day of the following month (for example, statements issued March 31 are due April 15<sup>th</sup>).
- Any amount not paid by the 15<sup>th</sup> day of the month following the statement is considered "past due". For the example above, the outstanding member receivable becomes past due on April 16<sup>th</sup>.
- If an account is not paid in full by the last day of the month in which the statement is received, the member name will be posted in a public area of the Club. After 30 days the member shall be denied further use of all Club facilities and may be suspended or expelled as outlined in the Bylaws of Glen Echo Country, Inc.

**MEMBERSHIP AGREEMENT**

If accepted as a member of Glen Echo Country Club, I agree to conform to all rules and regulations and to pay all fees as set by the Board of Directors and the corporation by-laws. I further agree to pay my dues and stock in accordance with the options approved by the Board of Directors and to pay all charges made by me, my family, and guests promptly when due. I understand that if my account is not current within 60 days from the billing date, my Club privileges will be automatically suspended. Past due bills will accrue a late fee each month in an amount equal to a minimum late fee established by the Club from time to time and/or interest at the maximum, non-usurious rate permitted by law from the date of the statement until paid in full. The undersigned further agrees to pay all reasonable attorneys' fees, court costs and other expenses incurred in connection with the collection my delinquent account.

**DRESS CODE / SMOKING / CELL PHONE POLICY**

In the interest of providing a traditional Country Club experience to members and guests, Glen Echo Country Club maintains dress code, smoking, and cell phone policies which may be amended by the Board of Directors from time to time. Complete information is provided in the Member Handbook and on the Club website. Members are responsible for ensuring compliance by family members and guests. Some key policies are listed below.

- Members, guests and visitors may not wear denim, athletic pants or sweat pants in the Clubhouse. Caps and visors are not allowed in the Clubhouse except in the Members Grill and Locker Rooms.
- Male golfers are required to wear appropriate attire. Collared shirts are required (with the exception of short-sleeve mock turtlenecks) and shorts must measure within 4 inches above the knee. Shirts must be tucked in at all times. Blue jeans or cut-off shorts are not permitted.
- Female golfers are required to wear appropriate attire. Ladies are asked to wear dress/mid-length golf shorts or slacks and blouses. Tasteful sleeveless and/or collarless blouses are acceptable. Tennis and running attire, cut-offs, denim, halter tops, low-cut blouses, tank tops, swimsuits, or T-Shirts are not permitted.
- All areas of the Clubhouse are designated non-smoking except for the Members' Grill which allows cigarette smoking during the day until 5:00p and the bar. Cigar smoking is not allowed in the clubhouse.
- Cell phones may only be used in corridors of the Clubhouse. Members and guests are asked to step out of the bar, dining rooms, or function rooms to place or receive calls. Members should also be considerate of other players on the golf course with regard to distractions caused by cell phone use.
